The offer of admission is *provisional* and is subject to the fulfilling of all the eligibility criteria with supporting documents as listed below:

- 1. You are informed to submit scanned colour copies of the relevant original documents *as per Annexure-1* by email to rcsrinagar@ignou.ac.in for verification.
- **2.** Apart from the above, send a full set of self attested photocopies of all required documents and copy of recently taken two passport size colored photograph to The Regional Director, IGNOU Regional Centre Srinagar, Kursu Rajbagh, Srinagar, J&K UT-190008 by post/courier immediately.
- 3. "This offer of admission is provisional and is based on the documents in respect of qualification and other eligibility criteria submitted by you along with the application form. If at a later stage, it is found that the document(s) submitted by you is/are false, your admission shall stand cancelled forthwith and no fee refund will be admissible in the event of such cancellation of admission."
- **4.** Candidate(s) falling under the category of **PH** is/are required to submit the necessary certificates from recognized medical authority in support of their claim with the minimum disability of 40% are only entitled for reservation.
- **5.** Female candidates under the category of War-widow will have to produce necessary certificate from the recognized defense authority in support of their claim to avail the reservation under this category are entitled for reservation.
- **6.** Regarding OBC (NC) category candidates, the category falling under the Central list are only eligible and the income ceiling limit laid down for OBC (Non Creamy) category should not exceed Rs. Eight Lakhs per annum.
- 7. The OBC applicants, who have not submitted NON-CREAMY certificate or Income Certificate or opted for D4A or D4 category, will be treated as Creamy OBC or General category

students and no change of category code shall be entertained from the candidates after the submission of Entrance cum Admission form.

- **8.** The SC/ST/OBC (Non-Creamy) candidates who have marks above the level up to which general category candidates are admitted, should not be counted towards reserved quota at all and are included in the general merit list of admissions.
- **9.** The Programme fee for 1st year is Rs. 20,000/-. Once you are allotted a seat during admission counseling the programme fee deposited will not be refunded under any circumstances. Submit the details in the prescribed format *(refer Annexure- 2)*
- 10. Please note that the weightage of the intensive theory & practical Counseling sessions, which is 75% and 90% attendance respectively, is compulsory, further there will be no change in the programme study centre once allotted, non refund of fee once paid. etc., and any other guidelines in respect of the programme, if sent by the School of Health Sciences for the information of the candidates etc. will be applicable.
- 11. The Fee Receipt cum Confirmation Letter and the Identity Card will be sent to you after the admission is finalized at later date.
- 12. It is compulsory to attend the admission counseling through online, the date and time will be intimated to you well in advance. In absentia of the candidate, the seat will be offered to the next person in the merit and no queries will be entertained in this regard.
- **13.** A register of attendance of all applicants who are attending the counseling will be maintained where the time of login for the counseling will be recorded.
- 14. No interim correspondence shall be entertained.
- **15.** Canvassing in any form will lead to the disqualification.
- 16. In case, the documents submitted by the candidate are found to be false, the admission will be cancelled and the entire documents will be sealed and forwarded to Registrar (SRD) for final decision
- 17. The University will not be responsible for any kind of postal delay and no further communication in this regard will be entertained.
- 18. No TA/DA will be paid, for verification of the documents, if called to the Regional Centre.
